**Brent Beardall**  
*WaFd Bank*

Brent Beardall is the President & Chief Executive Officer of WaFd Bank. Mr. Beardall joined WaFd Bank in 2001 as Vice President & Controller. In 2003, he was promoted to Chief Financial Officer, a position he served in for eleven years prior to being assigned to his current role with responsibility for all client-facing activities of the bank.
